PET RELEASE FORM - OWNER AGREEMENT

Is (are) in good health & have not been ill with any communicable condition for the last 30 days. I further certify that my pet (s) have not harmed or shown aggressive or threatening behavior towards any person or any other animal. I understand that I am solely responsible for any harm caused by my pet (s) while my pets are being groomed and in the possession of Princeton Grooming. We require your pet (s) to have a current rabies vaccination on file during each grooming. We advise but do not require that your pet be vaccinated against distemper, hepatitis, parainfluenza adenovirus type 2, parvovirus, corona, leptospirosis and bordetella prior to being groomed.

Princeton Grooming has and reserves the right to refuse grooming any animal that may be a threat to itself, other animals, or any human. If we are not able to take the cat out of its carrier or get a muzzle on a dog that we think may bite, then we may refuse service for the protection of all parties.

Princeton Grooming does not use tranquilizers on any pet.

Princeton Grooming Authorization for shaving and for flea and tick treatment We consider major matting & pelt removal to be a health risk for your pet. Major matting and pelt removal is extremely risky for your pet. You should be aware that the pet could suffer from razor burn, nicks, minor and major cuts, hematoma (bruising) to skin and or serious injury. Shaving often exposes pre-existing skin conditions. Cats especially have very thin skin and electric clippers can cut the skin while trying to shave under the mats. There is no way to avoid this, however slowly or carefully we proceed. If you choose to proceed with the removal, you do so at your own risk and expense for any veterinary care your pet could require during or after the grooming service. We on occasion use natural and chemical solutions to treat your pet for fleas and ticks should they be found. Some animals are more sensitive than others. Your pet could experience an allergic or other reaction that could be serious. You will be notified immediately should this occur. I release, indemnify and hold harmless Princeton Grooming, its owner, employees, representatives and affiliates from and against any and all liability or responsibility arising out of the performance of the services above. Your consent is not required to perform the flea and tick treatment in our shop.

Release I am the owner or caregiver of the pet or pets listed above. I have read and understand the foregoing cautions printed above. I realize that pet grooming may cause injury or allergic or other reactions to my Pet (s), but desire to have Princeton Grooming proceed with the grooming. I further understand and agree that Princeton Grooming and their owner, employees, representatives and affiliates will not be liable for any problems or injuries which may develop and I hereby release them of any liability of any kind whatsoever arising from my pet (s) attendance and participation at Princeton Grooming. I further understand and agree that any problems which develop with my pet (s) will be treated as deemed best by the staff of Princeton Grooming at their sole discretion, and that I assume full financial responsibility for any and all expenses involved. The staff will make best efforts to contact client via telephone prior to or during any emergency medical treatment.

Therefore, I consent to and authorize once again, the grooming of my pet (s) and I release, indemnify and hold harmless Princeton Grooming, its owner, employees, representatives and affiliates from and against any and all responsibility or liability, expenses, damages and costs, including reasonable attorney fees arising out of the performance of Grooming and Spa services. This release may not be changed or modified or amended orally, except in writing signed by both parties hereto. This release shall be governed under the laws of the state of New Jersey (except for conflict of law).
